There were three changes to bylaws and standing rules that were voted on by the membership.

Vicki Guntenaar, Interim Secretary on behalf of the Executive Committee and the Board of Directors made the following motions. They were all unanimously accepted by the membership as presented.

BYLAWS - PROPOSED CHANGE

ARTICLE VI - OFFICERS Section 3. Term of Office

CURRENT LANGUAGE:

All elected officers shall serve a term of two years, or until their successors are elected. Officers shall assume office at the conclusion of the Annual Meeting at which they are elected. No officer shall serve two consecutive terms in the same office, with the exception of the Treasurer and the Charitable treasurer, who may serve three consecutive terms.

PROPOSED ACTION # 1 TO AMEND AS FOLLOWS: (NOTE - Actual changes are in larger font & bold type.)

All elected officers shall serve a term of two years, or until their successors are elected. Officers shall assume office at the conclusion of the Annual Meeting at which they are elected. No officer shall serve two consecutive terms in the same office, with the exception of (1) the Treasurer and the Charitable treasurer, who may serve three consecutive terms and (2) the National Council Representatives who may serve three consecutive terms.
