## **NEW BUSINESS**

- 1. Nominating Committee: Susan Chambers will chair the nominating committee. She will engage other members to join her committee. Possible replacements and recommendations were discussed. - 2. - **3.** D4D table arrangements: We have commitments from Trailwood and Troy Garden Clubs so far. At the 2/1/19 committee meeting, branch representatives present were asked and agreed to reach out to their own branches for arrangements. There are specific specs for the arrangements to pass along to those participating. A brief discussion regarding the new event seating was also addressed.
- **4.** Board Development Activity in 2019: Post workshop survey results were discussed from 8/20/18. Valuable feedback was obtained on various topics MI DIV might offer with enough interest. Mary Schwark will continue to organize these special events.
- **5.** MI DIV & MI 4-H Foundation: A discussion began on our relationship with 4-H moving forward. With Sheila Kneeshaw becoming MI DIV President as well as 2nd VP of 4-H, she will do her best to keep the two roles separated. Her priority however is to WNF&GA and MI DIV.
- **6.** National Meeting in Toronto: Mary Schwark shared what information she had as of this meeting. There is no registration form yet. There is a meeting upcoming to discuss details. There is a Toronto visit happening now. Information should be coming out in the March newsletter titled Spring National Meeting.

Mary Schwark, President

There were also various conference calls.

Mary provided a summary of MI DIV/MI 4-H Foundation interactions and documents since 1/6/2018.

- **8.** Amendment signed 9/26/18 at Saginaw Fall Council Meeting did not get rid of the original Endowment. The original Endowment still exists, but IFYE has been replaced by Michigan 4-H Youth, in support of their study and travel abroad. The Endowment states that 4-H decides how funds will be distributed.
- 9. A Memorandum of Agreement (MOA) was signed by Michigan Division (MI DIV) and the Michigan 4-H Foundation (M4-HF) on 1/15/19. The MOA was created to describe the terms and conditions under which a newly-created Expendable Gift Agreement's Scholarship Fund (unallocated income generated primarily by International Teas since 2009) will be administered by the M4-HF with consultation by MI DIV board members.
- **10.** In addition, funds\* that were inadvertently deposited in wrong account have now been moved and all monies are accounted for. (\*Port Huron gift of \$5000.00)

Mary will continue as editor of our newsletter.

Grand Marais Branch- Mary received a letter from President Arlene Cobau regarding withdrawal of their branch from Michigan Division. A letter of disposition of funds in their treasury must be received before branch can withdraw. (The Grand Marais Branch has not dissolved.) Mary will send a letter to Arlene stating that fact and providing her the language in our by-laws of this requirement.

Pat Brown, MI Division Treasurer

Pat reported that there is a discrepancy in the year-end report that needs to be resolved. She will forward report to board members as soon as it is finished.

Lenore Treba, Charitable Foundation Treasurer

Lenore presented Charitable Reports. Reports were accepted as presented. They will be placed on file.

Lenore also included changes to show the four NEW pillars for donations to the WNF&GA Michigan Division Endowment (created with 4-H in 2007).

She has also provided an updated CHARITABLE DONATIONS document dated October 5, 2018.

Sheila Kneeshaw, 1st Vice President

Spring Council 2019 will be hosted by the Warren Branch. It will be held at The Gazebo. Date: May 22, 2018. Guest speaker will be Ann Cline of the Iris Society.

Sheila is still requesting Branch volunteers as well as a venue for the Fall Council 2019 meeting.

A discussion started regarding the International Tea 2019. Now that our Expendable Gift Agreement with M4-HF is secure, we can begin raising funds in support of scholar-ships for Michigan 4-H participants traveling to countries outside of the United States. Mary Schwark made the suggestion that we host "several" Tea's at multiple venues on the same day covering a wide area of metro Detroit and beyond to accommodate our MI DIV branch locations. Several board members will research various venues and report back to Mary Schwark within the next few weeks.

Marcia Mandell, 2nd Vice President

Branch Recognition Program: There were no recognitions received yet as of this meeting.

There was no update from Joette Kunse for the Speaker's Bureau.

Cheryl Malin, MI DIV Registrar

Cheryl Malin provided her report on membership. The current membership number as of February 4, 2019 is 1253 members including six members-at-large. There were 57 members removed since August 18, 2018.

Cheryl as well as the whole MI DIV board have been pushing the "go green" initiative to receive your newsletters electronically rather than a printed copy through the mail. As of August 30, 2018, 172 members were receiving their newsletters electronically. As of February 2, 2019 that number rose to 457. Cheryl has signed up 285 members since last August. Kudos to the Rochester branch. 97 of those making the switch were from this branch.

National Delegates, Jo Sillanpaa and Charlotte Westbrook
